The invoice(s) become past due if not paid by the 25th day of the date of the month following the invoice date, your account may be placed on hold and sent to our collection department. In the event of default in payment, and if the same is placed in the hands of an attorney for collection, the undersigned agrees to pay all costs of collection, including reasonable attorney's fee.
5. Materials, both stock and special order, will be billed after 30 days post receipt for items left for will call. Items not will called within but prior to 90 days of Hank's Electrical Supplies receipt, are considered returns and subject to the terms of line 3 of this agreement. Extended billing & will call terms may be negotiated on a 'per-order' basis.
